5. OLD BUSINESS:

a. Discussion - Personnel Policy on Use of Accrued Vacation

Discussion -Administrator Lorentzen explained the Town of Gilcrest current vacation policy states that employees with 0-9 years of service get 80 hours vacation each year. Vacation cannot be taken until an employee has worked for 1 year. Mayor Chavez thought this policy should be revised so employees do not have to work a full year before they can use any of their vacation. Mayor Chavez along with Trustees Lester and Tapia were in consensus that after 90 days new employee could start using their vacation. Trustees Fulton, Castro, Nothem, and Esquivel all agreed that employees should have to work 6 months which is the same as their probation period before they could use vacation.

Administrator Lorentzen will make a new resolution to amend the policy and bring it to the next board meeting for a vote.

b. Discussion – Amending Code to Allow Chickens in Residential Districts

Each board member was given the opportunity to tell whether they were in favor of changing the ordinance to allow chickens in town. Trustee Lester and Fulton were in favor of allowing chickens stating this is a rural community and residents should have the opportunity to be self-sufficient, there are already a lot of smells because we are surrounded by feed lots and they do not make any more noise than dogs. Trustees Castro, Nothem, Tapia, and Esquivel were not in favor of changing the ordinance. Stating there is no way to monitor or enforce how many chickens people have on their property, they are noisy, and they smell.

It was decided to send out a survey to see what the town wants. Administrator Lorentzen will draft a survey with proposed chicken regulations for the next meeting. If the board approves, the survey will be sent out in a special mailing.
