SNOW REMOVAL



Town does enforce snow removal in accordance with **Gilcrest Municipal Code 11-2**. The Town of Gilcrest requires residents to clear sidewalks within 24 hours of the end of a snowfall, and businesses to do so within 4 hours of the end of a snowfall. Please make sure that you are removing snow for the safety of pedestrians within the community as well as yourself. As a reminder Code Enforcement will be citing those that are in violation of the above mentioned code throughout the winter months.



Pet Licenses

If you own dogs AND/OR cats, they must be registered with the Town. A copy of rabies vaccination by a registered veterinarian is required. The cost for registering spayed or neutered dogs/cats is \$5.00 per animal, and the cost for intact dogs/cats is \$15.00 per animal. Dogs **MUST** be on a leash when taken off owners property. This is for the safety of other people as well as for the safety of the dog. All existing pet licenses expire on December 31st and must be renewed annually.



Town Code limits the number of dogs plus cats at a dwelling to four

Business License

The Town of Gilcrest requires a General Business license to do business in the Town. A General Business license fee is \$40.00 and will expire on December 31st of each calendar year.

A "business" means any for-profit or not-for-profit trade, vocation, occupation, profession, enterprise, service, or commercial activity in the Town.

Some examples of a business are: A person running a home occupation out of their residence, a business which makes regular deliveries, an out of town service, business or contractor who does a job where employees come into town or a business who use their own vehicles to make a delivery of purchased goods to an address.
